
### IV. JURISDICTION

The jurisdiction of the Trust shall be the whole of India.

### V. OBJECTIVES

- a. To establish, develop and manage schools, colleges, universities, training centers, Polytechniques, and other educational institutions for imparting general education in any discipline such as arts, science, crafts, teaching, medicine, engineering etc including vocational training for the benefit of the public and for the benefit of the Trust at large open to all persons irrespective of caste, race, creed or religion with all necessary buildings halls laboratories, libraries, reading rooms, play grounds, recreating centers dispensaries, hospitals, sanitoriums, hostels, dormitories, boarding houses lodging and residential quarters and with all fittings and fixtures, machinery apparatus, instruments, utensils, conveniences and amenities.
- b. To establish all types of educational institutions.
- c. To establish schools in primary, secondary and higher secondary levels with Kerala, CBSE and ICSE syllabuses.
- d. To establish play schools and nursery schools.
- e. To take loans from banks or other financial institutions for the realization of the objectives of the trust.





**XXIV. Auditing of accounts :** The income and expenditure accounts of the trust have to be audited by a chartered accountant appointed by the executive committee.

**XXV.** The income of the trust should not be distributed to the members or office bearers of the trust as dividend or as profit, but has to be utilized for educational and charitable purposes as mentioned in the objectives and also for the development of the trust.


**XXVI.** The Capital of the Trust is the Rs. 2000/- contributed by the trustees.


**XXVI. Winding up :** In the event of winding up for dissolution of the trust their remains any excess of assets after satisfaction of its debts and liabilities, such excess of assets shall be transferred to any institution or trust having objects of a charitable nature and as similar to the objects here in as possible or to government.

This trust deed is registered in the sub registrar office at Perumbavoor and all the members of the executive committee of the trust have put their signatures on the first and last pages of this deed and signatures of witnesses are also put on the last page and representing the executive committee, the Managing Trustee and the secretary put their signatures in all pages.
